Studio Rental Agreement

- 1. Payment:** All studio rental charges are payable in advance at the time the reservation is made. Fees are refundable in full only when notice is given two (2) business days prior to the reserved date. Payment by Credit Card via PayPal or Check sent to Photography Design Studio. Cancellations are considered valid once they have been confirmed by Photography Design Studio. There is a two (2) hour minimum for all studio reservations. RENTER agrees that the reserved time begins and ends at the times requested, including setup and tear down. Additional time may be added at the regular hourly rate, only if the studio is available.
- 2. Damage of Equipment /Studio:** RENTER agrees to pay for any repair costs of equipment or studio damages caused by the renter, renter's assistant(s), model(s), and/or subject(s). The RENTER agrees to leave the studio in the condition it was found, or a \$100 cleaning fee will be charged.
- 3. Liability:** Photography Design Studio will not be held liable for any injuries or accidents to the RENTER, renter's assistants, renter's models, or renter's clients that occur within or outside the studio premises.

The RENTER agrees not to hold Photography Design Studio liable for any injuries or accidents that occur within or outside the studio premises. The renter agrees to inform all models and/or assistants plus employees that Photography Design Studio will not be held liable for any injuries or accidents that occur within or outside the studio premises.

Photography Design Studio will assume no liability for any equipment brought in or left by the RENTER. By signing this document you agree and understand Photography Design Studio will not be responsible for any lost and/or damaged equipment.

The RENTER agrees to use models of legal age (18 years old) when using the studio. The RENTER agrees to full responsibility for ensuring the validity of age verification the model produces. The Renter agrees to not hold Photography Design Studio liable in the case of an invalid ID or any other form of age validation. The RENTER agrees to furnish proof of parental consent in the case that the model is under the age of 18 years.

The RENTER agrees to notify Photography Design Studio of any use of exotic animals, motorcycles, hazardous substances, and/or any other potentially dangerous materials prior to the shoot and of any requirements associated with such use.

I have read all the above four (3) sections and I fully understand them. I realize that this agreement need only be signed once and applies to future studio reservations.
